HLAA-GR CHAPTER MINUTES JANUARY 10, 2015

The January 10, 2015, Annual Business Meeting of HLAA-GR Chapter was called to order at 10:40 am. Those in attendance included: Alan Brown, HLAA-GR Vice President Emeritus; Joy Carlton; Thom Casey, HLAA-GR Professional Advisor; Brenda Eggleston, HLAA-GR Secretary; Matt Eggleston; Kevin Mowen; Liz Mowen; Nancy Quilici; and Linda Wallace, HLAA-GR President.

Following discussion, the motion was made, seconded, and passed to accept the 2015 slate of officers as presented: President, Linda Wallace; Vice President, Matt Eggleston; Treasurer, Casey Billups; and Secretary, Brenda Eggleston.

The motion to accept the Treasurer's Report as read was made, seconded and passed. Discussion ensued regarding the purchase of a portable room loop system for the chapter's use until the time an FM system can be purchased. Brenda and Matt Eggleston agreed to investigate the costs of portable room loop systems.

The motion to donate \$50.00 to Beulah United Methodist Church in appreciation for the use of a meeting room during 2014 was made, seconded, and passed.

Discussion ensued regarding the possibility of a chapter Hospital Kit Project. Linda Wallace agreed to contact the San Antonio, TX HLAA chapter and purchase one of their hospital kits for review by HLAA-GR. It was also agreed that Arva Priola would be contacted about a possible speaking engagement at HLAA-GR in 2015 to discuss HOH needs and hospital visits.

The motion to table the discussion of the formation of a Community Outreach Committee was made, seconded, and passed. To date, community outreach projects include VDDHH Focus Group on April 18; Healthy Living Fair at Unity Christ Church of Bon Air on April 18; and Winfree Memorial Baptist Church chapter presentation on October 6; Brenda Eggleston agreed to attend this function with Linda Wallace.

Suggestions for future HLAA-GR speakers included: Someone from HLAA National to

address the programs available to local chapters; police and firefighters (what training they have to work with HOH); Christine Ruderson (VDDHH); local audiologists.

Discussion ensued regarding possible grant funding for HLAA-GR. Alan Brown agreed to investigate possibilities

The motion to table discussion of chapter participation in the 2015 Walk4Hearing event in Washington, DC, was made, seconded, and passed.

Discussion ensued regarding the possibility of having permanent storage space for HLAA-GR materials available at Beulah United Methodist Church. Alan Brown agreed to check with the church for permission to have a storage cabinet for our use on the premises of Beulah. Thom Casey agreed to investigate finding a cabinet for such purpose.

The motion to adjourn the meeting at 12:45 pm was made, seconded, and passed.

HEARING AID ADVICE

(EXCERPTS FROM DR. KEITH ROACH'S COLUMN IN THE FEBRUARY 9, 2015, EDITION OF THE RICHMOND TIMES-DISPATCH)

"First, have realistic expectations about what a hearing aid can do. It does not make your hearing what it was 50 years ago."

"Second, find someone who really knows what he or she is doing. People whose technicians spent a lot of time teaching, discussing different options and adjusting [hearing aids] after purchase were the most satisfied."

"Third, be prepared to spend some money. Good hearing aids are expensive."

"Fourth, try many models." "Because it takes a long time to get used to them, you have to wear them pretty much constantly. Both your ears and your brain need time to adjust, so be patient."

"Finally, several people and one chapter president wrote to me about the Hearing Loss Association of America (www.hearingloss.org) and the benefit they gained from visiting their local chapter and sharing their experiences."

COLDS AND ANTIHISTAMINES

Short-acting antihistamines, such as Benadryl, block the production of histamines and can relieve the symptoms of a runny, itchy nose, but can cause sleepiness. Longer-acting antihistamines such as Claritin, Zyrtec, and Allegra don't usually cause sleepiness. Talk to your doctor before using such products if you have glaucoma, an enlarged prostate, breathing problems, high pressure, or heart disease, or swallowing problems. **Consult your doctor before using any of these products.** ~ AARP Bulletin, Vol. 56, No. 1

DIFFERENCES BETWEEN BLUETOOTH AND HEARING LOOP TECHNOLOGIES

There is some confusion about the benefits of Bluetooth (BT) technology versus hearing loops. While BT technology can wirelessly connect hearing aids with a smartphone, iPad or TV transmitter, BT devices are not designed for settings where there is a large audience (like a theater or meeting hall). This is because BT devices only connect one-to-one and cannot be shared. BT technology and wireless BT clip-on microphones can benefit users in an intimate setting between two people like in a noisy restaurant or in a car; however, they currently do not have applications in larger venues. [Hearing loop technology is available for many different situations, from listening to an individual person to listening in large venues...hearing loop technology can be shared.]

GOT TINNITUS?

At least 2 hearing aid manufacturers (Widex and Phonak) are producing hearing aids with "Zen Technology." This technology, along with training techniques from your hearing aid provider, trains your brain to divert your attention from all the roaring, buzzing, clicking noises you hear. Ask your audiologist or hearing aid specialist about this new technology. It is not a panacea...you need to work closely with your hearing aid provider and/or audiologist!
